Academic Apparel

The academic apparel worn today by the faculty and candidates has its origins in the everyday dress of the Medieval European university communities. Codified and standardized in this country late in the last century, it serves as a scholastic heraldry indicating in its elements the degree held, the discipline in which the degree is taken, and the institution granting the degree.

The gowns are of three kinds: the Bachelor's with open, pointed sleeves; the Master's with sleeves covering the arms only to the elbow then falling in narrow closed panels; and the Doctor's with very full sleeves gathered at the wrist and guarded with three velvet bars, the front panels of the gown being also of velvet. The gowns vary in color, and almost always are trimmed in velvet of the color of the particular discipline. The participants today, as recipients of the Juris Doctorate degree, wear this latter gown trimmed in royal purple for law.

The hood is the most colorful, informative, and perhaps most important element of academic dress. Its length, shape and the width of its edging indicate the degree held. The color of the velvet represents the discipline or field of study. For instance, the doctoral hoods awarded are four feet long. The velvet is five inches wide and royal purple for law. The silken lining is turned out and indicates by its colors and pattern the institution granting the degree. The Trustees and candidates wear the hood of California Western School of Law, incorporating our school colors (royal purple and gold).

The popular "Doctoral Tam" in soft velvet is the cap worn today. They are decorated with a purple tassel for a Doctor.

Commencement Speaker

Summer Stephan | San Diego County District Attorney

District Attorney Summer Stephan has devoted her life to protecting children and families, providing justice to the most vulnerable, and is a national leader in the fight against human trafficking and sexual exploitation. Summer rose through the ranks fighting for justice in the trenches before San Diego County voters overwhelmingly elected Summer as District Attorney in 2018 and again in 2022. As District Attorney, she leads the second-largest DA's Office in California, and the fifth-largest in the United States, managing a professional staff of 1,000 employees, serving as the People's Prosecutor for San Diego County and its more than three million residents. Summer leverages her extensive courtroom, management, and leadership experience to set clear public safety priorities in collaboration with law enforcement and the community, keeping San Diego County one of the safest urban regions in the United States. In 2022, Summer was named one of "The Five Best Prosecutors in America," utilizing evaluation factors of integrity, fidelity to the rule of law, responsible innovations, and community relations.

She served as Chief of the DA's North County Branch and Chief of the Sex Crimes and Human Trafficking Division, a special victims unit she pioneered.

As the District Attorney, Summer opened a state-of-the-art Family Justice Center in the North County for victims of domestic violence and elder abuse. Summer launched a juvenile diversion program that diverted hundreds of kids away from the school to prison pipeline. Her office tripled the prosecutions of hate crimes. Summer formed a specialized team to effectively combat Organized Retail Crime.

Summer holds leadership positions in public safety nationally and locally, including serving as President-Elect of the National District Attorneys Association, and co-chair of the National Association of Women Judges Human Trafficking committee. She is the recipient of numerous local, state, and federal awards.

Summer received her Bachelor of Arts degree from the University of California, Davis and her Juris Doctor from the University of the Pacific, McGeorge School of Law.

JD Candidates

The JD is the doctoral degree necessary for the practice of law in the United States. Students are attracted to the degree because it is the most common preparation for sitting for state bar exams and providing legal counsel to clients. After completing a bachelor's degree, the student typically takes three additional years of specialized, legal course work, although at California Western, students can complete the program in 2 years by taking summer classes, or 4 to 5 years, by enrolling in the part-time program.
